 - List of people who have the correct Safeguarding training for Thursday Lunches – provided straight after the PCC meeting it was raised in so completed

- Only one was willing to take on Safeguarding Lead at the choir week, several others were asked and declined.
- thanks to Cathy minuted, for her hard work
- Adults in the choir are now seen by the diocese as Church Officers, (changed in January 2025), so all adults will need to do Basic Safeguarding training – PCC agreed that those who refuse will need to leave the choir
- Confidentiality needs to be respected both by the PCC and the wider community for Cathy to continue in the role
